Please specify that you are with the TJCSA, and if you plan to stay any additional nights other than Thursday night, which is being paid for by the Association. You will need to pay the hotel for any additional nights other than the one night the Association covers and incidental costs that may arise from your stay. The Association rate is \$83.00. If no communication is received by Hampton Inn & Suites regarding your room reservations, it will be assumed you do not plan to attend.

Room Preference: Please advise if you would prefer a single room, instead of a double room, as the single rooms are limited.
